(3)指標は全て単元株式数で調整して集計した。
(4)株式分割・公募・転換社債型新株予約権付社債の株式転換等により株式数に変動がある場合は、その都度1株当たり当期純利益及び純資産の変更を行っている。

Notes: (1)"6-1 Average Consolidated PER and PBR" and "6-2 Average PER and PBR" are surveyed on the companies listed on 1st and 2nd Section excluding those are assigned to Securities to be Delisted. Newly listed company is included from one business day before the last business day of the next month of listing. Figures in "6-1 Average Consolidated PER and PBR", figures from Non-Consolidated financial statements are used in calculation if a company does not adopt consolidated financial statements. In "6-2 Average PER and PBR" are based on Non-Consolidated financial statements.
(2)Figures of Net Income and Shareholders' Equity are based on the fixed figures during the term from February of 2007 to January of 2008.
(3)Figures are converted on a basis of trading unit of 1,000 shares.
(4)If the number of listed shares is changed due to the allotment to the Shareholders, public offering, conversion of Convertible Bonds and so forth, "Earnings Per Share" and "Net Assets Per Share" are adjusted each time accordingly.
