(2)本表の作成に当たって使用した当期純利益及び純資産は、平成21年9月期までの確定数値である。
(3)指標は全て単元株式数で調整して集計した。
(4)株式分割・公募・転換社債型新株予約権付社債の株式転換等により株式数に変動がある場合は、その都度1株当たり当期純利益及び純資産の変更を行っている。
(5)掲載指標の計算式は次のとおりである。

Notes: (1)This statistical data covers companies listed on the 1st and 2nd Sections of the TSE whose stock prices are used to calculate stock price indices at the end of each month: We calculate the average for PER and PBR as follows: We produce "Consolidated", figures based on Consolidated financial information if companies prepare it, and Non-Consolidated information if they do not prepare consolidated information. For "Non-Consolidated" figures we use the financial data that is solely for each of all of the companies.
(2)Figures of Net Income and Shareholders' Equity are based on the fixed figures during the term from October of 2008 to September of 2009.
(3)Figures are converted on a basis of trading unit of 1,000 shares.
(4)If the number of listed shares is changed due to the allotment to the Shareholders, public offering, conversion of Convertible Bonds and so forth, "Earnings Per Share" and "Net Assets Per Share" are adjusted each time accordingly.
