(2)Until March, 2007, public offerings made when companies making an initial public offering, OSE Hercules-listed companies, or Jasdak-listed companies listed on their respective stock exchanges were excluded from calculation. From April, 2007, public offerings made when companies list directly on a stock exchange other than the OSE Hercules market and the Jasdak market are included in calculation.
(3)Number of cases for "Warrants and Stock Options Exercised" are monthly aggregates. Annual figures are number of companies. Figures in "Warrants and Stock Options Exercised" exclude cases where treasury stocks are allotted in accordance with the exercise without issuing new shares.
